

MESSAGE FROM THE CEO AND BOARD CHAIR

In a study published this past year in JAMA Ophthalmology, researchers found that more than 7 million people are living with uncorrectable vision loss in the U.S., including more than 1 million Americans who are living with blindness. Yet vision loss and blindness are often preventable. And so Prevent Blindness continued its sight-saving mission in 2021 by expanding its work to identify and remove barriers to eye care for people of all ages, to provide access to quality, preventive eye care that can correct poor vision or help detect sight-threatening eye disease and thus give everyone an opportunity to live their best possible life with the best vision possible.

When patients living with thyroid eye disease (TED) faced pandemic-related shortages of Teprotumumab (TEPEZZA), the only approved therapeutic treatment for the condition. Prevent Blindness successfully advocated for resumed production of the vital medicine under the "Coronavirus Aid, Relief, and Economic Security Act" (CARES Act). We also joined with 117 organizations to urge Congress to increase funding for the Centers for Disease Control and Prevention (CDC) Vision and Eye Health Initiative. As a result of Prevent Blindness advocacy efforts, the Senate appropriations legislation provided \$6 million for the CDC program.

Empowering individuals and families to take care of their sight

also involves raising awareness for eye and vision health and the steps we all should take to protect our eyes. Through media releases, social media campaigns, awareness weeks and months and the publication of new content on our website, preventblindness. org, Prevent Blindness helped improve understanding of familiar conditions such as dry eye, agerelated macular degeneration (AMD), diabetes-related eye disease and cataracts, as well as less familiar diseases such as inherited retinal diseases. inflammatory eye disease, thyroid eye disease, and geographic atrophy (GA), an advanced form of dry AMD.

We trained patients and professionals as eye health advocates for themselves and others through our **A.S.P.E.C.T. Patient Engagement Program** (A.S.P.E.C.T. stands for Advocacy, Support, Perspective, Empowerment, Communication, and Training.) You can learn more on our YouTube channel about A.S.P.E.C.T. members as they tell their powerful and moving stories of help and hope.

In addition to its effort to expand and improve access to eyecare and vision health through its ongoing work with the Vision Equity Task Force, The Center for Vision and Population Health at Prevent Blindness launched a new Vision Integration Library: Vision & Eye Health Resource Center. health, healthcare, and community service providers with the goal of improving vision outcomes for people of all ages.

The Prevent Blindness **Focus on Eye Health National Summit** celebrated its 10th anniversary. Under the theme "Our Changing Vision," the summit convened more experts and stakeholders than ever before around pressing vision and population health issues of national and international significance. Michael F. Chiang, M.D., Director of the National Eye Institute, and paralympic athlete Amy Dixon provided keynote addresses for the two-day virtual event.

The National Center for Children's Vision and Eye Health at Prevent Blindness continued to elevate understanding and adoption of evidence-based children's vision programs around the country. The National Center also guided the formation of a new Children's Vision Equity Alliance to create initiatives that target underserved populations and communities, aligning the care they receive with that of children with already strong access. As schools reopened to in-person learning last year, the National Center updated its **Considerations for Conducting Children's Vision Screening Safely in Schools, Head Start and Early Care and Education Programs During the Covid-19 Pandemic**. Prevent Blindness and state affiliates accelerated the longstanding national children's vision screening and certification program that trains school nurses, Head Start staff, pediatric office staff and volunteers to conduct effective, evidence-based vision screenings and provide appropriate follow-up to help make sure children screened receive professional eyecare as needed.

In recognition of all we have done, and must continue to do, to promote and support healthy vision for our youngest and most vulnerable, Prevent Blindness has declared 2022 as **The Year of Children's Vision**. This yearlong campaign will address the various and specific vision and eye health needs of children and seek to improve outcomes through advocacy, public health, education, and awareness.

On November 4, 2021, Jeff Todd, president and CEO of Prevent Blindness, presented Sherry Williams with the F. Park Lewis Lifetime Achievement Professional Service Award for her decades of leadership. Sherill K. Williams has served as president and CEO of Prevent Blindness Ohio since 1986 and is retiring at the end of 2021. Working in concert with a 30-member board of directors, Sherry coordinated 20 paid staff/subcontractors and 3600 volunteers across Ohio to implement sight-saving programming by providing direct services to more than 1,000,000 Ohioans annually and educating millions of consumers about what they can do to protect and preserve their gift of sight.

Prior to joining the staff of PBO, Sherry served as national director of youth volunteers for the March of Dimes Birth Defects Foundation from 1978–85, and as executive director of the Fairfield County, Connecticut. chapter of the March of Dimes in 1986.

Sherry serves as a member of the Ohio Association of Nonprofit Organization's Standards of Excellence Advisory Committee which evaluates charitable nonprofit effectiveness and awards certifications; as an advisor for the Ann Ellis Fund of The Columbus Foundation which provides grant funding for glaucoma research studies in Central Ohio; and as a member of the Ohio Public Health Association Vision Section. Sherry is a registered lobbyist and a founding member of several eye health collaborations including the SOS (Save Our Sight) Coalition, Ohio Eye Care Coalition, Ohio Fireworks Safety Coalition and Ohio Aging Eye Public Private Partnership.

Sherry has co-authored two books published by BoardSource dealing with charitable nonprofit governance – "Getting the Best from Your Board" and "Building the Governance Partnership: The Chief Executive's Guide to Getting the Best from the Board".

Sherry is also a published co-author of the following peer-reviewed journal articles: "Outcomes of a Vision Screening Program for Underserved Populations in the U.S." - Ophthalmic Epidemiology 2013 and "Barriers to Attending an Eye Examination after Vision Screening Referral within a Vulnerable Population" - Journal of Health Care for the Poor and Underserved 2013.

Sherry received her bachelor of arts in speech/communication from the University of Minnesota and a master's in public administration/ health care administration from Pace University in New York.

In addition to her 35 years as CEO of the Prevent Blindness Ohio affiliate, Sherry Williams has served tirelessly to further the sight-saving mission of our national organization and all state affiliates, by co-chairing the Prevent Blindness Affiliate Association and chairing its Nominating Committee, and by serving on the Finance & Administration, Marketing & Development, Public Health & Policy committees among others. She joined our **Eyes on Capitol Hill** advocacy event annually to advance the cause of eye and vision health at our nation's capital.
